

**AMENDMENT TO
OPERATING AGREEMENT**

THIS AGREEMENT made effective the 30th day of June 2003

BETWEEN:

CITY OF TORONTO
(the "City")

OF THE FIRST PART

and

TORONTO COMMUNITY HOUSING CORPORATION
("TCHC")

OF THE SECOND PART

WHEREAS the City and TCHC are parties to an Operating Agreement made effective the 1st day of May 2002 (the "Operating Agreement");

AND WHEREAS the parties wish to state the number of rent/geared-to-income and modified units that TCHC shall provide;

AND WHEREAS pursuant to section 4.5 of the Operating Agreement the parties agreed to commence negotiations in the first quarter of 2003 in respect of funding for the years 2004 and beyond on a multi-year basis and to amend the Operating Agreement accordingly not later than June 30, 2003, subject to the other provisions of the said section;

AND WHEREAS pursuant to section 5.1 of the Operating Agreement the parties agreed to meet in the first quarter of 2003 to work out an annual report format that meets the City's reporting requirements under the Act subject to the other provisions of the said section;

NOW THEREFORE, THIS AGREEMENT WITNESSETH that in consideration of the premises and the mutual covenants herein contained, the parties hereby agree as hereinafter set forth:

1.0 INTERPRETATION

1.1 Definitions

In this Amending Agreement, unless there is something in the subject-matter or context inconsistent therewith, terms and expressions used that are defined terms and expressions under the Act or Regulations shall have the same meaning as in the Act or Regulations; and terms and expressions used that are defined terms and expressions under the Operating Agreement shall have the same meaning as in the Operating Agreement.

1.2 Definitions under this Amending Agreement

“**Auditor**” means the auditor approved by the City as shareholder of TCHC.

“**Fiscal Year**” shall mean the period of twelve (12) consecutive months commencing on the first day of January and ending on the last day of December;

“**Mortgage Subsidy**” means the subsidy referred to in clause 3.3(a)(i);

“**Property Tax Subsidy**” means the subsidy referred to in clause 3.3(a)(ii);

“**Residual Operating Subsidy**” means the subsidy referred to in clause 3.3(a)(iii);

“**Tax Exempt**” means exempt from taxation for municipal and school purposes under a City of Toronto by-law made pursuant to City of Toronto By-law No. 282-2002, as the same may be amended, superceded or replaced.

1.3 Scope of Agreement

The parties acknowledge that the City is entering into this Agreement as Program Administrator as required by the Shareholder Direction.

2.0 NUMBER OF RENT GEARED TO INCOME UNITS AND MODIFIED UNITS

2.1 Amendment

a) Section 2.1 of the Operating Agreement is hereby replaced by the following:

“2.1 TCHC shall at all times ensure that it provides rent-geared-to-income assistance under Part V of the Act to at least 50,174 households of which at least 47,650 households shall have incomes no greater than the household income limit. Such assistance may be provided with respect to units in the Portfolio, replacement units authorized by the Minister in connection with any Ministerial consent to redevelopment of any part of the Portfolio under the Act, or any replacement units to be provided pursuant to an agreement made pursuant to section 37 of the *Planning Act* (or any successor provision or legislation). Subject to Sections 2.2 and 2.3 of the Operating Agreement, TCHC will manage the number of households receiving rent-geared-to-income assistance on a Portfolio basis to ensure that the foregoing overall service levels remain at the required level.”

b) Section 2.4 of the Operating Agreement is hereby replaced with the following:

“2.4 TCHC shall at all times ensure that it provides at least 227 modified units.”

3.0 FUNDING

3.1 Amendment

This Section 3.0 represents the parties' agreement pursuant to subsection 4.5 of the Operating Agreement with respect to funding for the years 2004 and beyond on a multi-year basis. In accordance with such subsection, all estimates, budgets and approvals will be made, provided, or given in adherence to the principles contained in the Shareholder Direction and the goals and objectives of TCHC's Community Management Plan Rent supplement payments under the Rent Supplement programs administered by the City with respect to units in housing projects owned, leased or operated by TCHC will be reported on and funded separately under separate agreements between TCHC and the City.

3.2 Funding Level for 2004

The parties agree that the aggregate funding required by TCHC for calendar year 2004 was equal to the total amount of principal and interest payments made during that **Fiscal Year** under the mortgages described in Appendix "1", the actual amount of property taxes paid by TCHC in respect of the Housing Projects described in Appendix "2" for that **Fiscal Year**, plus an amount of \$ 59,710,128 as a residual operating support; and that such amounts are not subject to adjustment.

3.3 Funding Levels for 2005 and beyond

Subject to the approval by City Council of each annual budget submitted by Shelter, Housing and Support, and to any consents or approvals required from the Minister, funding levels for the 2005 **Fiscal Year** and each **Fiscal Year** thereafter will be based on the following:

- a) The subsidy for the Housing Projects described in Appendices "1" and "2" for any **Fiscal Year** which commences after December 31, 2004, shall be the total of:
 - i) the **Mortgage Subsidy** as calculated in sub-section (b);
 - ii) the **Property Tax Subsidy** as calculated in sub-section (c); and
 - iii) the Residual Operating Cost Subsidy as calculated in sub-section (d).
- b) The **Mortgage Subsidy** shall be equal to the total amount of principal and interest payments to be made during the **Fiscal Year** under the mortgages described in Appendix "1" as the same may be renewed, replaced, amended or supplemented.
- c) Subject to sub-section (e), the **Property Tax Subsidy** shall be equal to the actual amount of property taxes payable by TCHC in respect of the Housing Projects described in Appendix "2" for the **Fiscal Year**.
- d) The Residual Operating Cost Subsidy is intended to fund a portion of the remaining operating costs of the Housing Projects described in Appendices "1" and "2" excluding mortgage costs and property taxes ("Residual Operating Costs"). TCHC is expected to

fund from other sources of revenue that part of its Operating Costs not covered by the Residual Operating Cost Subsidy. Subject to sub-section (e), the Residual Operating Cost Subsidy shall be equal to:

- i) in the 2005 **Fiscal Year**, the amount of \$ 61,895,519; and
- ii) in each **Fiscal Year** subsequent to 2005, the Residual Operating Cost of the prior **Fiscal Year** adjusted by the cost index for such **Fiscal Year** prescribed by the Minister pursuant to clause 2 of subsection 106(3) of the Act. Cost index increases are intended to include the increased utility costs of the Housing Projects described in Appendix "1".

Provided that in the event the maximum amount payable to a benefit unit for shelter assistance is increased or decreased pursuant to regulatory amendments under the Ontario Works Act, 1997 or the Ontario Disability Support Program Act, 1997, or the rent scales for the rent attributable to a benefit unit is increased or decreased pursuant to regulatory amendments to the Act, the parties agree to meet at the request of either party, within three (3) months following receipt of written notice of such request, to negotiate an adjustment to the amount of the Residual Operating Subsidy to take into account the increase or decrease in the rental income of TCHC as a result of such regulatory amendment.

- e) When a Housing Project described in Appendix "2" becomes Tax Exempt:
 - i) The amount of the **Property Tax Subsidy** shall be reduced and the amount of the Residual Operating Cost Subsidy shall be increased by the amount of property taxes that would otherwise be payable with respect to such property, based upon its assessed value at the time that it becomes Tax Exempt;
 - ii) In the event the property is sold, the **Residual Operating Subsidy** will be reduced by an amount based upon the original increase in the **Residual Operating Subsidy** when the property became Tax Exempt, pursuant to clause (i) above, as such amount has been adjusted each **Fiscal Year** by the prescribed cost index in accordance with sub-section 3.2(d);
 - iii) In the event the property ceases to be Tax Exempt, the **Property Tax Subsidy** will be increased by the amount payable as taxes for municipal and school purposes with respect to such property and the **Residual Operating Subsidy** will be reduced by an amount based upon the original increase in the **Residual Operating Subsidy** when the property became Tax Exempt, pursuant to clause (i) above, as such amount has been adjusted each **Fiscal Year** by the prescribed cost index in accordance with sub-section 3.2(d).

3.4 **Payment Schedule**

- a) On or before the first business day in January of each **Fiscal Year**, the City shall make a payment to TCHC of that portion of the **Mortgage Subsidy** that relates to the mortgages

described in Part B of Appendix “1” as the same may be renewed, replaced, amended or supplemented.

- b) payments of the balance of the funding, with respect to the **Mortgage Subsidy**, the **Property Tax Subsidy** and the **Residual Operating Subsidy** for each **Fiscal Year** shall be made in equal monthly installments on the first business day of the month, with monthly adjustments for increased or decreased mortgage payments based on actual renewal;

3.5 Ministerial Approval

The parties acknowledge that the funding formula provided for herein requires Ministerial approval in connection with the housing projects that are subject to Part VI of the Act. Accordingly, the proposed funding model is subject to Ministerial approval. If the Minister does not approve the funding formula, the parties acknowledge that they may be required by the Minister to comply with the provisions of Part VI in respect of those housing projects governed under that Part. In such event, the annual funding for any year will not be increased or decreased, but the calculations required to be made under Part VI will be made and the appropriate apportionment of the funding across the Portfolio will be made accordingly. The City will seek Ministerial approval in connection with the proposed funding.

4.0 REPORTS, RECORDS

4.1 Amendment

This Section 4.0 represents the parties’ agreement pursuant to subsection 5.1 of the Operating Agreement with respect to annual reporting requirements.

4.2 Annual Information Return

TCHC shall provide to the City, within five (5) months of the end of its **Fiscal Year**, the information, documents and reports described herein in the form of a single annual report. Each annual report will include information with respect to TCHC including identification number, year end, mailing address, a description of the housing programs administered, contact name and position, and such contact’s telephone number, fax number and email address. Each annual report will be signed by two members of the Board on behalf of the Board of TCHC representing that, to the best of their knowledge and belief, the information provided in the report is true and correct. The information to be included in the annual report shall include the following:

- a) Balance Sheet prepared in accordance with generally accepted accounting principles in Canada;
- b) Income Statement prepared in accordance with generally accepted accounting principles in Canada;

- c) A Statistical Report providing, by program, the information in the form specified in Appendix "3";
- d) Statements setting forth the administration costs incurred in the **Fiscal Year** with respect to the Centralized Waiting List Agreement and the Rent Supplement Agreement, each dated as of May 1, 2002, between the City and TCHC.
- e) Such other information requested from time to time by the City as shall be reasonably necessary to permit the City to comply with its reporting requirements under the Act and Regulations;

4.3 Auditors' Statements

Each annual report shall be accompanied by:

- a) a report from the Auditor confirming
 - i. the total amount of principal and interest payments made during the **Fiscal Year** under the mortgages in respect of the Housing Projects described in Appendix "1";
 - ii. the actual amount of property taxes paid by TCHC in respect of the Housing Projects described in Appendix "2" for the **Fiscal Year**; and
 - iii. the administration costs incurred in the **Fiscal Year** with respect to maintaining the Centralized Waiting List.
- b) Auditor's report on TCHC's financial statements.
- c) Confirmation of the aggregate of each of the Market Rent revenue, rent-geared-to-income revenue and the Rent Supplement subsidy under each Rent Supplement program.

4.4 Ministerial Approval

The parties acknowledge that an Annual Information Return is currently required for the Portfolio and that any other form of reporting requires Ministerial approval. Accordingly, the parties acknowledge that they may be required to comply with the reporting requirements under the Act unless the Minister approves an alternate reporting format. The City will seek Ministerial approval for whatever form of reporting the parties wish to use.

5.0 GENERAL

5.1 Compliance with Shareholder Direction, etc.

Nothing in this Amending Agreement shall relieve TCHC from its obligations and duties under the Shareholder Direction, the Act, the Regulations, its incorporating documents and bylaws, the Federal Operating Agreements and the Non-Profit Rent Supplement Agreements.

5.2 No Restrictions on City

Nothing in this Amending Agreement shall be construed as limiting the powers and remedies of the City under the Shareholder Direction, the Act, the Regulations, the Federal Operating Agreements and the Non-Profit Rent Supplement Agreements or otherwise available to the City, from time to time.

5.3 Amendments to Federal Operating Agreements and Non-Profit Rent Supplement Agreements

The parties agree that if any provisions of this Amending Agreement are inconsistent with Federal Operating Agreements or Non-Profit Rent Supplement Agreements, such Federal Operating Agreements and Non-Profit Rent Supplement Agreements shall be deemed to have been amended by the parties in accordance with the provisions of this Amending Agreement.

5.4 Amendment to Provincial Accountability Rules

The parties agree that if any provisions of this Amending Agreement are inconsistent with the provincial accountability rules prescribed in Ontario Regulation 644/00 pursuant to Section 32 of the Act, such provisions of this Amending Agreement shall be deemed to be amendments, deletions or additions to the provincial accountability rules and shall be effective as of the Effective Date. To the extent that any provincial accountability rule is not inconsistent with the provisions of this Amending Agreement, the parties shall continue to be bound by such provincial accountability rule.

5.5 Amendments

No modification or amendment to this Amending Agreement shall be made unless agreed to by the parties in writing.

5.6 Successors

This Amending Agreement shall be binding and enure to the benefit of the parties and their respective successors.

5.7 Assignment

TCHC shall not assign any or all of its rights or any or all of its obligations under this Amending Agreement to any person without the prior written consent of the City.

5.8 No Interference

All rights and benefits and obligations of the City under this Amending Agreement shall be rights, benefits and obligations of the City in its capacity as a service manager under the Act and shall not derogate from or interfere with or fetter the rights, benefits and obligations of the City in its functions and capacity as a municipal corporation.

5.9 Further Assurances

TCHC shall execute and deliver all such further documents and do such further acts and things as the City may reasonably request from time to time to give full effect to this Amending Agreement.

5.10 Waivers and Consents

No term or provision of this Amending Agreement shall be deemed waived and no breach consented to, unless such waiver or consent shall be in writing and signed by an authorized member or staff of the party claimed to have waived or consented. No consent by a party to, or waiver of, a breach under this Amending Agreement shall constitute a consent to, waiver of, or excuse for any other, different or subsequent breach.

5.11 No Partnership or Joint Venture

This Amending Agreement is not intended to create, nor does it create, a joint venture or partnership between TCHC and the City. It is acknowledged and agreed that TCHC does not acquire any right, title or interest in any property of the City by virtue of this Amending Agreement.

5.12 Invalidity

If any part of this Amending Agreement is held or rendered invalid or illegal by a court of competent jurisdiction, the remainder of this Amending Agreement continues to apply.

5.13 Headings

The headings in this Amending Agreement are for convenience of reference only and shall not affect the construction or interpretation of this Amending Agreement.

5.14 Time

Time shall be of the essence of this Amending Agreement.

5.15 Number and Gender

In this Amending Agreement, words in or implying the singular include the plural and *vice versa*, and words having a gender include all genders.

5.16 Effective Date

Notwithstanding the actual date of execution of this document, this Amending Agreement shall be in effect as of the date first above mentioned.


