ITEM 4	VIOLENCE REDUCTION PROGRAM UPDATE – Q4, 2021	CSAC:2022-03

The above-captioned report (CSAC:2022-03) was circulated to CSAC members prior to the meeting.

A verbal deputation from Miguel Avila-Velarde was received with respect to this item.

Ms. Penny provided an overview of the report and was available to answer questions of the CSAC. Highlights of the discussion include:

- It was further provided that the Community Service Coordinators
 ("CSC") referred in the report are contract staff attained through the
 Summer Safety Enhancement Plan to provide community and social
 supports to tenants in the regions. TCHC will look at whether these
 positions need to be made permanent. There are currently 8 CSCs and
 they report to the regional management not the CSU.
- The CSAC had a discussion regarding Table 2A: Shootings that were known to be retaliatory (2019-2020) in the VRP sites. Staff provided

that the data was extracted from the CSU's records management system. The table does not include information from Toronto Police. Toronto Police would not provide the data to TCHC as the disclosure of retaliatory shooting information may affect ongoing police investigations.

 Action Item: management to provide to the CSAC a list of shooting events in the VRP sites from 2018, broken down by event type and by month, to identify if a pattern exists in those communities.
