Sika-kumaa Nyafu ne Abusua Tax (LIFT)

- Ete akatua tax so fam beye \$850 ma adwumayefo aa omo akatua sua na ewo fam ne beye \$1,700 ma awarefo

Ontario Abofra Mfasoo

- Etua sika dodo beye \$1,434 ma abofra biara wo afe biara mu de ma abusua aa omo akatua wo fam anaa eye kakraa, se omo eeye adwuma anaa se omo nye adwuma aa

Ontario Trillium Mfasoɔ (OTB)

- Nea ɛka Ontario Trillium Mfasoɔ no ho ne Ontario Adetɔn Tax Krediti, aa ɛte tax aa Ontario kuromma aa ɔmo akatua wɔ fam tua de ma adetɔn. Sika poduo dodoɔ aa ɔmo tae tua afe biala ne \$313 de ma opanyin ne abofra biara aa ɛwɔ abusua no mu.

Canada Abofra Mfasoɔ (CCB)

- Mfasoɔ aa wo nya no afe biara mu ne \$6,765 de ma abofra biara aa ondii mfie 6 na ɔmo aa edi 6 kɔpem 17 no deɛ ye \$5,708.
- Abofra aa w'adi dɛm mfasoɔ no nso ka CCB ho. Mfasoɔ dodoɔ aa wobetumi enya no bosome biara mu ne \$240 de ma abofra biara aa ɔwo ho kwan biara.

Canada Adwumayɛfo Mfasoɔ (CWB)

- Saa tax krediti yi aa yetumi san de ma wo no te tax so de ma amanfo ne abusuafo aa ɔmo ye adwuma na ɔmo akatua sua. Akatua dodoɔ aa wobetumi enya wɔ wei mu ne \$1381 de ma ɔmo aa ɔmo nko na ɛte ne \$2379 de ma abusuafo.
- CWB sanso de dɛmdie nneɛma aa ɛboa ka ho.. Sika dodoɔ aa wobetumi enya ne \$713 de ma amanfo aa ɔmo nkoa na ɛte anaa abusuafo.

GST/HST Krediti

- Saa tax aa yeyi fri mu akatua aa yetua no bosome mmiensa biara no boa abusuafo aa ɔmo akatua nhyɛda ndɔso no te GST anaa HST na ɔmo tua no so kakraa

- sɛ wo nkoa na wote aa sika dodoɔ aa wotua no afe no mu ne \$451, sɛ wa ware anaa wohyɛ Kɔmɔn-mmra no ase aa wotua \$592, ɛna abofra biara aa w'adi 19 ɛɛba fam no tua \$155.

Akatua Nkaho Nneɛma aa Yesi so Pi (GIS)

- Bosome biara mfasoɔ aa mpanyinfo aa akɔ ɔmo ahomegyɛɛ mu aa ɔmo akatua wɔ fam wɔ Canada man nya aa yente tax wɔ so. Akatua dodoɔ aa ɔmo tua no bosome biara no ye \$919.

Ontario Mpanyinfoɔ Transit Tax Krediti

- Saa tax krediti yi aa yetumi san de ma wo yi boa mpanyinfo aa edi 65 ne akyire no wɔ ɔmo akɔneaba ka ho.
- Wobetumi agye sika dodoɔ aa ɛso \$3,000 wɔ amansan transit ka aa wo wɔ ho kwan mu na wanya akɔ pem \$450 afe biara mu.
