Community Legal Clinics are funded by Legal Aid Ontario to provide free legal advice and representation. Legal clinics may assist with tenancy problems and problems with Ontario Works or Ontario Disability Support Program benefits. Clinics also have access to interpreters.

**It is usually best to contact the legal clinic by telephone first before attending their office.**
