"Like many services that were in-person before COVID-19, the resolution of landlord and tenant disputes went virtual during the pandemic to protect public health. But a plan by the province to switch to a permanent online-first system has sparked concern from some who say it's unfair and will make it easier to evict residents."

"My observation is that there is not an even playing field between tenants that don't have access to devices, may not have steady internet connections and a whole host of other accessibility issues, compared to the parties on the other side."

An email I sent to Ms. Gouveia and Ms. Amponsah once I read through this agenda item. Understandably they didn't have answers immediately. It wouldn't hurt for this Board to learn eventually what those answers may have been.

"I'm trying to understand a few things.

the Interest of Black People)

Number one - Wouldn't a Centre for Advancing the Interest[s] of Black People in TCHC perpetuate the myth that it's only Black people that live and work at TCHC? [Or, worse yet, that ALL Black people live in TCHC?

Number two - Wouldn't such an initiative have more public appeal if it was a city run initiative instead of isolating its impact within TCHC?

Number three - How does creating another silo at TCHC assist with the notion of collaboration that is needed to affect any significant change?

Number four - How do you plan to expand beyond Black issues to bring in other notions of colour/cultural difference? (What was that theory called again?)

Number five - What is so wrong with creating a Tenant Advocacy Office that could incorporate every notion of difference - age (with OCHE support), ability (with R-PATH support) and race/culture (with CABR support)? I'd much

rather work with you to achieve your goals. Isolating yourselves within a multi-million dollar cage surrounded by like minded individuals still means you're in a cage. When it's been clearly stated it's not Black people that should be changing I'm concerned that your intentions may be lost in translation.

Number six - That leads me to question where allies fall into your plans moving forward?"

Here's a couple additional questions -

Number seven – What happens when identifying people as Black is no longer politically correct?

Number eight – Would the almost \$2.5 million set aside for this initiative not be better spent with an internal TCHC COVID Task Force? That seems to be the most pressing issue impacting Black people in TCHC at this particular moment and for the foreseeable future. (Even if this becomes a primary focus of the new Centres mandate how many tenants and staff will be impacted by COVID19 before then?)

Number nine - Other than the Board requesting budget and staff guidelines at the last board meeting I don't see the purpose in getting this far ahead of yourselves. It will be a long time before we can meet in person never mind opening up the "Centre" in a physical space. (Certainly those salaries will be adjusted to reflect the percentage of the year the staff actually perform their specified duties.)

Number ten – I think you should create a panel with equal

representation of TCHC staff and tenants to assist with the decision making processes of the Centre for Advancing the Interests of Black People.

Number eleven – How long must we wait for the detailed CABR Work Plan or is this work going to be delegated to the "Centre"?

In summation, I don't believe that now is the time, nor, TCHC the place for the creation of the Centre for Advancing the Interests of Black People. But, if everyone insists on this proposal moving forward I would prefer it be something you can look back on in the years ahead with pride. Not something that you just slapped together because it was politically expedient.

TCHC BofD - April 27<sup>th</sup>, 2021 (Item 5 – Strategic Priorities)

It took the death of 81 year old Al Gosling in a TCHC stairwell for TCHC to create the Office of the Commissioner of Housing Equity. (OCHE)

It took the death of George Floyd in the US and the subsequent death of a young Black woman, 29 year old Regis Korchinski-Paquet, in a fall from a TCHC balcony to create the momentum for Confronting Anti-Black Racism. (CABR)

It took the death of two year old Crystal from an air conditioner falling out of an 8<sup>th</sup> floor TCHC building for TCHC to create their Air Conditioner Exchange Program.

How many COVID related deaths of persons in TCHC communities will have to take place before someone deems it necessary to create a TCHC COVID Task Force?

How many COVID related deaths before TCHC includes an COVID **ACTION** Plan as one of their Strategic Priorities?

If, as COO John Angkaw stated in an email last week "staff work very closely with Toronto Public Health and meet with them several times a week" there is a great deal of information that is being shared that shouldn't require a Freedom of Information request, or an Ombudsman's report, to compile and put forth recommendations.

I'm none too happy about not being allowed to create a sign for the bulletin board of my building stating "COVID IS HERE!"

As a newly minted co-tenant rep in my building I believe I'm negligent in my duties by not alerting my fellow tenants about the urgent need to ensure they are following appropriate protocols.

There are still far too many TCHC tenants/guests that socialize with other tenants in their units, and that crowd into elevators. Never mind the additional habits of wearing the same disposable mask for longer than its single use lifespan or not washing their reusable masks after each use. That's if they wear a mask at all.

Toronto Public Health has ordered Toronto District School Boards to close. Toronto Public Health has mandated that businesses with five or more cases of COVID close. That's where people learn, and where people work. How long before Toronto Public Health and TCHC can come together on a COVID prevention pilot program (accepting the stated fact that they are meeting "several times a week") to restrict the potential of COVID transmission where we live?

Seeing as you have issues with me posting COVID IS HERE! posters maybe you could start by including "hallways" along with laundry room, lobbies and elevators as common areas on your current mask posters. Maybe common shouldn't be the word you use. The distinction should actually be between public space and private space. Public space is anything beyond that which the tenant pays rent. Maybe this would have the added benefit of clearly identifying for TCHC where to put additional CCTV equipment. We pay rent for our individual units (Private Space) that does not include additional square footage in the hallway (Public Space).

Thank you to Ms. Penny, staff, tenants & community

It is imperative we acknowledge in order to help inform policies, processes and culture. I would be remiss not to state (my opinion) the importance of continuing these insightful community connections with staff and tenants. Ground up approach will empower and help inform with context and practicality.

What is TCHC doing to ensure the four pillars: Community Safety & Support, Tenancy Management, Cleaning & Maintenance are reflecting such?

Furthermore, I want to acknowledge that communication has improved but is not where it needs to be which leads me to question; what appropriate support may look like. There were changes made to the transfer policy however there is a continued need to revise. How many tenants and staff would be open to helping inform the updates? Complaints around maintenance aren't necessarily new, as TCHC continues to restructure, technology may play a role however there is a digital divide amongst who we serve. Communication (including complaint handling) should be done with respect, care and considerations. This spans beyond training/coaching and it does incorporate culture; we've acknowledge Toronto's diversity now we need to hoan in on the intricacies of our community connections (past, present and future). Acknowledge sending TCHC feedback as they continue working hard to make updates to their platforms (internal and external) about the pivotal role a 'pend' function may have, as client and staff go through changes including but not limited to, major financial and/or life changes. I want to highlight the need for continued funding and decisions that are conducive to maximize funding. These are things that are impactful, build relationships which directly and indirectly strengthen trust and capacity, amongst other things, including culture. We have (at times heavy) work ahead; want this to be a place you feel safe, you can heal and harness belonging. Ideally, we want our tenants, staff and community to thrive.
