- (1)that Toronto Community Housing forward a report to the City with respect to progress on:
  - (i) consulting with Toronto Fire Services to develop a comprehensive education program with an emphasis on fire safety programs for TCHC tenants;
  - (ii) working with Toronto Fire Services to develop and implement a pilot project to determine the most appropriate smoke alarm type: ionization or photoelectric smoke alarms to be used in existing TCHC units; and
- (2)that staff report back to the Committee on inserting sprinkler systems in future developments, including costing, and factoring the timing and provisions of the anticipated changes to the Ontario Building Code with respect to sprinkler systems.
