Public Session Items

Through this budget process, TCHC management has been working closely with the City to identify how we can continue to deliver service delivery commitments to tenants and build on the progress that has been made over the past year.

ITEM 1A APPROVAL OF PUBLIC MEETING AGENDA

TCHC'S 2023 OPERATING AND CAPITAL ITEM 2 BUDGETS

TCHC:2022-90

The above-captioned report was circulated to Board members prior to the meeting.

Mr. Sharma and Mr. Yip were available to answer questions of the Board. Highlights of the discussion include:

 This is a challenging budget year. Management are focused on ensuring we can continue to deliver great services to tenants, managing the organization as efficiently as possible, and working with the City of Toronto (the "City") to deliver on our services. Work will also continue with the State of Good Repair ("SOGR") program and in-flight development projects.

- Management will work with the City and the Toronto Seniors Housing Corporation ("TSHC") to find efficiencies through to the 2024 budget.
- The decrease in residential rent for market units is a function of the transfer of the scattered houses portfolio, which comprised a significant number of TCHC's market rent units.
- The Board noted that it would be helpful in the 2024 budget to include a like to like comparison of market rent units, taking into consideration the transfer of the scattered housed portfolio, to identify whether there are increases in market rent revenue.
- The split of units is approximately 90% rent-geared-to-income ("RGI") and 10% market rent.
- The Board directed that rather than continuing to use TCHC staff resources, that a special request be made to the City for one-time financial support for a temporary resource to analyze the financial impact of TCHC's operational and capital support in standing up the TSHC. It will be important to have someone external to TCHC, TSHC and the City perform this work that is objective and independent, and who can move this work forward at an expedited pace.
- It will also be important to eventually look at the permanent funding model to ensure TCHC's long-term financial sustainability.
- On behalf of the Board, the Chair thanked staff for the hard work they put into developing this year's budget submission.

ON MOTION DULY MADE by Ms. Imrie, seconded by Ms. Douglas and carried, the Board unanimously approved the following recommendations, as set out in Report TCHC:2022-90:

- Approve the 2023 Operating Budget as outlined in the Presentation that is Attachment 1 to Report TCHC:2022-90;
- Approve the 2023 Capital Budget as outlined in the Presentation that is Attachment 1 to Report TCHC:2022-90, which includes:

- (a) the 2023 to 2026 Building Renewal Capital Budget; and
- (b) the 2023 Development Capital Budget, as outlined in this report; and
- 3. To better inform the financial strategy required to benefit the City, the Board Chair, on behalf of the Board, seek one-time financial support from the City in order to undertake a detailed financial analysis of the efficiencies and effectiveness to be achieved in respect of services delivered by TCHC and the Toronto Seniors Housing Corporation ("TSHC"); and
- 4. Authorize the appropriate staff to take the necessary actions to give effect to the above recommendations.
