#### BUSINESS ARISING FROM THE PUBLIC MEETING MINUTES ITEM 5 AND ACTION ITEMS UPDATE

The GCHRC discussed Action Item 1 – Demographic Data for Vendors of TCHC. Highlights of the discussion include:

- The Committee reiterated that the request was to collect vendor demographic information to understand how representative the vendor pool is and whether a vendor policy exists to ensure vendors procured are representative of the business community in Toronto, which includes vendors of a smaller size, racialized vendors, and women led companies.
- Strategic Procurement has been working on identifying opportunities to involve more medium-sized vendors in TCHC's procurement process. Strategic Procurement is also working on a broader Social Procurement Policy and as part of that policy staff are looking at how TCHC can promote opportunities for a greater number of businesses, which include tenant-led companies, racialized vendors, women-led businesses, etc.
- The Centre for Advancing the Interests of Black People at TCHC is involved in the discussion of the Social Procurement Policy to ensure a Confronting Anti-Black Racism lens is applied in policy development.
- The Committee requested that the timeline of the Social Procurement Policy be reported back to the GCHRC once it is available.

# NEW BUSINESS – IMPACT OF<br/>MODERNTO STRATEGY ON 931ITEM 10YONGE AND TENANT SERVICESVERBAL MOTION

The Chair proposed to add an item of new business to the meeting Agenda related to the impact of the ModernTO strategy on 931 Yonge Street and tenant services. Highlights of the discussion include:

- At its meeting of April 6 and 7, 2022, City Council adopted a development strategy for a number of properties, which included 931 Yonge Street and contemplated a market offering process for 931 Yonge Street. The report contemplates that TCHC staff working in its head office will be relocated to the civic center network. Despite TCHC's adoption of a Hub Model, 931 Yonge Street continues to provide a service location for tenants, including the location for in-person Board and Committee meetings.
- It was provided that at this point the timing of relocating TCHC's head office is late 2023 or early 2024. Given the recent change of the market, it was recommended that TCHC management follow up with the City of Toronto (the "City") to understand if the timeframe has been changed.
- TCHC management has been having discussions with the City to understand implications of the relocation. It was recommended that TCHC work with the City on a list of requirements for its future head office, which includes tenant access to the new location.
- The Committee resolved to request that the Board direct management to report to the Tenant Services Committee, requesting that City staff attend, on the manner in which service to TCHC's tenants will be addressed as part of the proposed relocation of TCHC staff from 931 Yonge Street to the civic center network in order to ensure that tenants needs are considered as part of this process in light of the City's Tenants First Principles.
