Once the City's meeting schedule has been released, Governance staff will work expeditiously to present the Board of Directors with the 2023 Board and Committee meeting schedule for approval.

These dates will take into consideration the Board's annual work plan, as well as religious and other holidays that may be celebrated by Board members and members of the public who wish to attend TCHC Board meetings.
