PURPOSE:

The purpose of this report is to provide an update on the progress and performance of the Violence Reduction Program ("VRP") for Q3 and Q4 2023 from both Programs and Partnership ("PAP") and the Community Safety Unit ("CSU").

RECOMMENDATIONS:

It is recommended that the CSAC receive this report for information and forward it to the Tenant Services Committee ("TSC") for information.

REASONS FOR RECOMMENDATIONS:

At its meeting of June 27, 2019, Toronto Community Housing's Board of Directors directed staff to operationalize the Violence Reduction Program ("VRP"). This report provides an update on activities and performance of the VRP.

BACKGROUND:

The VRP has been developed with the objective of enhancing the safety and security of tenants residing in Toronto Community Housing ("TCHC") properties. This initiative was launched in response to the disproportionate incidents of violence at TCHC properties, which are primarily rooted in

poverty, addiction, mental health issues, and street involvement among the tenant population.

The VRP adopts a comprehensive approach that encompasses enhanced enforcement activities through the deployment of dedicated, on-site CSU staff, close collaboration with the Toronto Police Service ("TPS"), and the implementation of economic development programs and community and social support measures in partnership with the City of Toronto (the "City").

The VRP recognizes the need for a multifaceted response that can address the underlying social and economic issues that give rise to violence in these communities. Through the collaborative efforts of TCHC, TPS, and the City of Toronto, the VRP aims to improve living conditions and quality of life for TCHC tenants, while also fostering a safer and more secure environment for all residents.

PROGRAMS AND PARTNERSHIPS VRP UPDATE:

Safety Training

VRP staff facilitated safety training in various communities, including Stop The Bleed in Regent Park and Human Trafficking Awareness in Parma Court and Flemingdon Park.

During the meeting on March 8, 2023, CSAC requested management to explore opportunities for expanding safety training. In response, VRP staff have developed a framework to support one community in the East Region and two in the West Region, offering enhanced safety training focusing on tenant leadership and capacity building. This framework has been used to apply for grant funds, with ongoing funding opportunities being explored.

Integrated Safety Coordination Teams ("ISCT")

VRP staff continue to attend monthly Integrated Safety Coordination Team ("ISCT") meetings with stakeholders including Toronto Police Service, the Toronto District School Board and the City of Toronto. In addition to regular meetings, ad hoc sessions in Q3 and Q4 were facilitated to coordinate responses to incidents of community violence.

Plans are underway to provide in-person training for all ISCT in Q1 2024, with a shift towards violence prevention rather than response.

Integrated Team Meetings ("ITM")

VRP staff have joined TCHC's internal Integrated Team Meetings ("ITM") in 18 out of 20 communities, while solutions are under discussion for two communities currently not covered. Site staff within VRP communities have contributed valuable insights about individuals, units, behaviours, and environmental factors fueling violence locally. This information informs VRP staff in developing work plans to reduce violence.

Insights acquired during ITMs are shared by VRP staff at ISCT meetings when TCHC requires additional support in addressing safety-related concerns.

THE EXPANSION OF VRP/CATEGORIZATION SITES (PILOT):

In 2023, TCHC staff conducted a comprehensive review of building categorizations to identify any changes in community classifications. This was presented to the CSAC and discussed at its September 29, 2023 meeting (Report CSAC:C2024-09).

The primary objective of the review was to determine whether communities categorized as 3 and 4 needed to be reclassified. Following a review of categorization, certain communities were reclassified. Consequently, CSU expanded VRP coverage to five additional pilot sites effective Q4 2023:

- 1901 Weston
- Yorkwoods Village
- 245 Dunn
- Centennial Apartments/O'Connor
- Flemingdon Park

To accommodate these changes within CSU's current staffing capacity, CSU has implemented a modified delivery model for these pilot sites. A Mobile Community Engagement and Response Team ("MCERT") has been established to focus on communities requiring concentrated efforts from CSU, in collaboration with internal and external agencies. Comprised of three CSU officers and one supervisor, MCERT deployment is data driven to increase community engagement, address anti-social behavior and

criminal activities, and coordinate with allied agencies and services to foster meaningful change.

Additionally, the Programs and Partnership team has initiated assessments and actions at these pilot sites:

Eagle Manor

The VRP is supporting a West Region effort to bring additional resources to the building, including enhanced patrols and a partnership with TPS. New community partners are being engaged, with VRP staff providing direct support to vulnerable tenants.

Yorkwoods Village

In response to community concerns about ongoing gun violence, VRP staff collaborated with partners in the Toronto Office to Prevent Violence to remediate and upgrade lighting in the complex, coordinate patrols between CSU and the Toronto Police Service, and establish community-led programming. Collaboration with the West Region aims to establish new space in the community where residents can lead and access programming that promotes community safety and wellbeing.

Dunn Avenue

VRP staff hosted two community feedback sessions on safety, followed by consultations with youth to establish space and programming for youth in the area.

Centennial Apartments/O'Connor Drive

VRP staff led a community meeting to identify needs around safety and violence prevention and is partnering with Covenant House to deliver human trafficking awareness sessions.

Flemingdon Park

VRP staff are establishing a youth computer lab, with ongoing discussions with community and institutional partners to bring safety and wellbeing programs to the space.

For a regional breakdown of Community Services Coordinators' activity in Q3 and Q4 2023, refer to Attachment 2, Tables 1a and 1b.

Continued assessment of the pilot sites will inform future progress reports and any adjustments to the sites or to deployment/resources.

COMMUNITY SAFETY UNIT VRP UPDATE:

CSU Staffing Update

Recent departures of VRP officers and the establishment of the MCERT, which drew most of its officers from the VRP, have resulted in 13 open positions within VRP sites currently filled by patrol staff as needed. A service-wide redeployment of staff in February 2024, while not fully resolving the shortage, will substantially address it. Despite this, the CSU VRP Community Sergeants continue to work closely with officers in their respective communities and provide support in organizing and managing various community events.

Twelve VRP positions remain on hold as directed by the Board.

CSU Update in High Needs Communities [1]

VRP Special Constables continued to attend weekly Integrated Team Meetings ("ITM") in Dan Harrison, Bleecker/Wellesley, Moss Park, Regent Park, Lawrence Avenue East, and monthly ITM for 2195 Jane Street. They actively collaborate with external and internal partners in the community, and efforts are underway to enhance the collaboration with TPS Divisional Neighborhood Officers for effective and coordinated community policing. The MCERT team remains active in both VRP and high-risk communities.

In Q3 and Q4 2023, CSU VRP staff led various events as outlined in Attachment 1, Table 4. The CSU's involvement in community events is a critical function as it both fosters a sense of community and presents the CSU in a less official capacity to our residents. This is beneficial in establishing relationships with residents and improving lines of communication, particularly those that may be distrustful of authority figures or reluctant to report issues that are important to them. The events are tailored to individual communities and focus on building a sense of safety, delivering much needed goods (food, winter clothing, school supplies, etc.) and providing education.

Revitalization communities within the VRP continue to benefit from increased CSU presence and interactions, partly due to the relocation of the central

district to Regent Park from the Moss Park Community. The Regent Park and Lawrence Heights VRP staff continue to engage with residents, TCHC supports and other stakeholders. Refer to Attachment 2, Table 2d for proactive work in VRP Revitalization communities in Q3 and Q4 2023.

CSU PERFORMANCE MEASUREMENT AND ANALYSIS (Q3 AND Q4, 2023):

1. CSU Calls for Service – VRP

A detailed breakdown of calls for service and actions taken in VRP Communities during Q3 and Q4 2023 is provided in Attachment 2, Tables 2 and 2a, with pilot sites shown separately in Table 2b.

In Q3 2023, calls for service increased by 316 calls compared to Q3 2022, marking an 8% increase primarily attributed to incidents of Cause Disturbance, Loitering, Theft, Mischief, Video downloads and Trespass to Property. However, Neighbour Dispute incidents decreased from the same time last year (Q3 2022) and last quarter (Q2 2023).

In Q4 2023, the upward trend continued with an increase of 437 calls compared to same time last year (Q4 2022), constituting an 11% rise driven by calls for Cause Disturbance/Loitering incidents, Welfare Check incidents and Trespass to Property incidents. Neighbour Dispute incidents continued to decline.

2. Crime on TCHC Property

Attachment 2, Table 2c provides a detailed breakdown of crimes against persons and property in VRP communities, including seniors, family, and family pilot sites.

Crimes against Persons:

In Q3 2023, there was an increase of 42 incidents in overall crimes against persons compared to the same time last year (Q3 2022), driven primarily by increases in reported assaults, threats, and robberies. However, there was a decrease of 15 reported crimes against persons compared to the preceding quarter (Q2 2023).

While the reported incidents of crimes against persons reached 102 in Q3 2023, it marks an improvement from pre-pandemic levels, where 135 incidents were reported in Q3 2020.

In Q4 2023, there was a significant decrease of 14 incidents compared to the previous quarter (Q3 2023), mainly attributed to decreases in reported robbery and assault incidents. Comparing the current figures to prepandemic levels, there were 125 incidents of crime against persons in Q4 2020, whereas Q4 2023 saw a decrease with 88 reported incidents.

Crimes against Property:

In Q3 2023, there was a significant increase of 62 incidents (55%) compared to same time last year (Q3 2022), primarily due to reported Thefts and Mischiefs. However, Arson and Theft from Vehicle incidents decreased.

There was a decrease of four (4) reported Crimes against Property between Q2 and Q3 2023.

In Q4 2023, property crimes increased by 44 incidents (34%) compared to same time last year (Q4 2022), again primarily due to more reported Thefts and Mischiefs.

Despite a high number of crimes against property in Q4 2023, a minor decrease of two incidents compared to Q3 2023 was observed.

3. Crime Prevention Efforts

The CSU remains committed to reducing and preventing crime on TCHC properties, particularly within the VRP sites, utilizing safety audits that incorporate Crime Prevention through Environmental Design ("CPTED") principles to inform recommendations aimed at fostering a safer environment.

CSU patrols serve as proactive measures to deter crime and build relationships with tenants, site staff, and stakeholders. These patrols, conducted on foot or mobile, totalled 2,456 in Q3 2023, including joint efforts with Toronto Police. Patrol schedules are contingent on VRP officer availability, TPS availability, and community needs, with 1,764 patrols conducted in Q4 2023.

Community Safety Advisors ("CSA") prioritize engagement activities as a means of improving communication and addressing safety issues within communities. Engagement activities initiated by CSAs encompass a range of initiatives such as community events, presentations, critical incident response, safety meetings, tenant management meetings and tenant visits. While Q3 2023 saw a slight decrease of six activities compared to the previous year, Q4 2023 saw a significant increase of 69 activities. Engagement activity data in Attachment 2, Table 2 excludes activities initiated or participated in by Special Constables.

Working with the regional teams, TCHC's legal department plays a critical role in crime prevention and intervention by issuing eviction notices, including N6 (illegal acts), N7 (health and safety) and N5 notices for antisocial behaviours such as interfering with others, damage to property, and overcrowding. These notices underscore TCHC's commitment to maintaining a secure living environment for all tenants. Refer to Attachment 2, Table 2 for a detailed breakdown on notices for eviction.

Progress on Reporting Shooting Incidents in VRP Communities:

The Community Safety Unit and the City of Toronto have reconvened to improve the accuracy of shooting data. Both entities collaborated to create a geographic layer supporting this work. TCHC has provided the geographical data to the City for mapping and will confirm viability with TPS once complete. Once confirmed, the statistics will be reported on, and the geographical layer will identify shooting incidents in TCHC communities or building clusters on the map.

IMPLICATIONS AND RISKS:

With twelve CSU VRP positions vacant and on hold as directed by the Board, existing front line patrol staff within CSU fulfill these duties as needed.

While serving current VRP sites and five pilot sites, maintaining coverage poses challenges as officers may be called to respond to priority calls or critical incidents throughout the City, potentially leaving any VRP locations unattended or underserved, leading to possible increases in anti-social activities.

Table 1: Q3 & Q4 2023, Violence Reduction Program Initiatives – West Region

Initiatives – West Region

135 people attended the Construction and Skilled Trades Fair at the Rexdale Community Hub.

VRP created a partnership with CultureLink to offer summer programming for children in Shoreham. The BikeHub program offered a 7-week Learn to Ride program, catered to children ages 6 to 12.

In partnership with Revitalization, the Seniors Wellness Breakfast Program at 5 Needle Firway - Firgrove community engaged seniors and staff, provided information about safety, and mitigated isolation, which is often a risk factor in unit takeovers.

The VRP west team established a partnership with KMPG to deliver a Money Management and Entrepreneurship Program for youth.

VRP's advocacy and organization led to community space being established in Yorkwoods Village and Kipling Mount Olive. Staff are working on partnerships to animate the space in 2024.

VRP empowered tenant advocacy that led to community lighting remediation with upgrades planned for 2024, along with investment in youth-led programming rolling out in 2024 in partnership with the Boys & Girls Club and the City of Toronto.

The Stage program delivered healing and social-emotional supports through theatre to youth in High Park Quebec.

VRP supported the delivery of the TrueVision career development program.

Table 2: Q3 & Q4 2023, Violence Reduction Program Initiatives – Central Region

Initiatives – Central Region

A new youth safe space was launched in Regent Park where the youth-led grassroots team Building Leaders for Change hosted weekly sessions.

The Kings Court documentary was filmed at Bleecker's basketball court, featuring two youth subjects navigating masculinity and friendship through the lens of basketball.

The Wanasah Black Youth and mental health services partnership continued to see approximately 50 youth per month in Regent Park.

Initiatives – Central Region

The St. Jamestown harm reduction program saw approximately 45 monthly clients. VRP worked with community partners and tenant representatives to transition the program to a community- and tenant-led model.

Two safety meetings were held at 245 Dunn to gather tenant feedback on the issues driving violence in the building and to inform plans for this new VRP site. Plans include grant applications for a proposed youth space and programming in the community.

Joined a Tim Hortons Camp weekend outing jointly hosted by the Justice Fund and the Black Daddies Club. VRP established relationships that will evolve into ongoing partnerships.

Table 3: Q3 & Q4 2023, Violence Reduction Program Initiatives – East Region

Initiatives – East Region

Community safety survey events were held in six VRP East communities, engaging over 400 families.

VRP collaborated on a youth leadership and conflict mediation project. 20 youth from Chester Le, Danzig, Empringham and Parma Court participated in the workshop and a week-long out-of-city camp.

The 8-week Restorative Justice Project engaged 15 youth impacted by gun violence in Danzig and Empringham. Graduates from this program will go on to become mentors for next cohort.

A safety meeting was held in our new pilot site of Wakunda/Parma. This meeting allowed tenants to meet VRP staff and set the tone for future community safety planning.

Engaged three heads of households, primarily responsible for anti-social behaviour concerns of youth ages 8 to 16 years in one of our East communities.

VRP set up a youth computer lab in Flemingdon Park and secured donations of several desktop computers to outfit the space. VRP is working to identify community partners to provide programming in the space.
