Background

- In August 2022, TCHC began the recruitment process for a TCHC Tenant Advisory Committee (TAC) to support the implementation of their refreshed Tenant Engagement System
- In March 2023, City Council directed that:
 - TCHC complete an additional another round of recruitment in partnership with the City to expand and diversify the TAC membership
 - City staff support the TAC, including assisting with the Terms of Reference development
 - Deputy City Manager and TCHC CEO co-chair the TAC on a transitional basis





TCHC TAC Membership

- The TAC is made up of 21 members:
 - 15 through TCHC's initial recruitment in 2022
 - 6 through TCHC and City's recruitment in 2023
- The TAC membership is diverse and inclusive:
 - TCHC communities from East (7 members), West (6 members) and Central (8 members) regions represented
 - Range of different age groups including youth
 - Range of experiences with TCHC's formal tenant engagement system
- Tenant Directors and a representative from R-PATH have been invited as non-voting members





Terms of Reference

- Terms of Reference (TOR) were developed with TAC members over the course of four working group meetings in August and September 2023
- Terms of Reference sections include:
 - Mandate and Objectives To advise TCHC on the implementation of the refreshed Tenant Engagement System and other corporate initiatives
 - Values and Code of Conduct Uphold values of TCHC Tenant Charter
 - Attendance and Quorum 14 members for quorum, with the ability to miss up to 3 meetings per calendar year
 - Decision Making Through voting with 60% majority
 - Conflict Resolution Progressive system to respond to violations of the TAC's code of conduct
 - Honorarium \$40 per meeting attended with TTC fare provided for in-person participants
- Formal approval of TOR was a key agenda item at the September 28 meeting





September 28 TAC Meeting

- First official TAC business meeting with CEO of TCHC and Deputy City Manager, Development and Growth Services as co-chairs and non-voting members invited to participate
- Hybrid attendance option: 13 attended in-person, 3 attended online
- Key agenda and discussion items included:
 - Approval of TAC Terms of Reference
 - Overview of TCHC Tenant Engagement System
 - Presentation by TCHC staff with Q&A for TAC members
 - Discussion of Future Agenda Setting
 - Review of schedule of remaining 2023 meeting dates and key agenda items
 - TAC members participating in a survey as part of the CEO recruitment process
